ABATEMENT PROCESS HELPFUL HINTS

- ❖ This information is provided to you to help you understand the abatement process and selecting an abatement provider. **(If you choose to use a provider.)**
- ❖ Call and get bids/estimates from several of the providers on the list. (We do not know how much they charge)
- ❖ Choose a provider. Once you have chosen a provider, please contact the providers you are not going use to do the work to let them know you have gone with another provider. Also, remember who you have hired to do your lot(s).
- ❖ After choosing a provider, they will be able to obtain an extension (if needed) to do the work on your property or any other paperwork needed.
- ❖ Once the provider has finished your lot, they will submit a request for a re-inspection. Once your lot has been re-inspected and passed, we will then print out a “Letter of Compliance” and give it to your provider. They will then send the “Letter of Compliance” with the invoice to you.
- ❖ It is in your best interest not to pay the provider until you have a “Letter of Compliance” in your hands from our department.

Note: We send out notices throughout the year to correspond with the changing seasons or weather conditions. It is possible that you will receive more than one notice during the year based on these conditions. Grass lots will be cited in early spring and wooded/brush lots will be cited in the fall/winter.
